

**AMENDMENT NO. 1 TO
NON-PROFESSIONAL SERVICES/MAINTENANCE SERVICES BETWEEN
ANIMAL FRIENDS OF THE VALLEY
AND THE CITY OF MENIFEE FOR CITY OF MENIFEE:
FY2021/22 ANIMAL FIELD SERVICES**

This is Amendment No.1 to that certain AGREEMENT for NON-PROFESSIONAL SERVICES/MAINTENANCE SERVICES("Agreement") made on **July 1, 2020** by and between the City of Menifee ("City") and **ANIMAL FRIENDS OF THE VALLEY** ("Contractor") for **CITY OF MENIFEE: FY2021/22 ANIMAL FIELD SERVICES** which Amendment No.1 is made and entered into on July 21, **2021** to increase the compensation amount as indicated below:

1. Section 1.6, "Covid-19 Safety" is included to read as follows:


1.6 Covid-19 Safety. If Consultant enters City property or meets in person with City employees during the performance of the Services, Consultant shall comply with all State, County, and local emergency orders, directives, protocols, and best practices related to the COVID-19 pandemic, including, but not limited to: (A) wearing facial coverings, (B) maintaining adequate physical distancing when possible, (C) regular hand washing, and (D) regular hand sanitizing.

2. Section 2, "Compensation" is amended to read as follows, increasing the contract amount by: **\$234,000.00 (TWO HUNDRED THIRTY FOUR THOUSAND DOLLARS AND ZERO CENTS)**


Section 2. City hereby agrees to pay Contractor a sum not to exceed **\$459,000.00 (FOUR HUNDRED FIFTY-NINE THOUSAND DOLLARS AND ZERO CENTS)** notwithstanding any contrary indications that may be contained in Contractor's proposal, for services to be performed and reimbursable costs incurred under this Agreement. In the event of a conflict between this Agreement and Exhibit A, regarding the amount of compensation, this Agreement shall prevail. City shall pay Contractor for services rendered pursuant to this Agreement at the time and in the manner set forth herein. The payments specified below shall be the only payments from City to Contractor for services rendered pursuant to this Agreement. Contractor shall submit all invoices to City in the manner specified herein. Except as specifically authorized in advance by City, Contractor shall not bill City for duplicate services performed by more than one person.

3. All other terms and conditions of the Agreement remain in full force and effect.




