

**AMENDMENT NO. 3 TO  
CONTRACT SERVICES AGREEMENT FOR  
CITY OF MENIFEE  
CITYWIDE TREE TRIMMING AND MAINTENANCE SERVICES**

This is Amendment No. 3 ("Amendment No. 3") to that certain Contract Services Agreement ("Agreement") made on **January 18, 2023** between the City of Menifee ("City") and **WEST COAST ARBORISTS, INC.**, a California Corporation ("Contractor") for **CITY OF MENIFEE CITYWIDE TREE TRIMMING AND MAINTENANCE SERVICES** as amended by that certain Amendment No.1 to the Agreement entered into on **July 20, 2023** ("Amendment No. 1"), as amended by that certain Amendment No.2 to the Agreement entered into on **March 22, 2024** ("Amendment No. 2"), which this Amendment No. 3 is made and entered into on May 20, **2024** to revise the City-Wide Tree Trimming and Maintenance Services table in Exhibit B to the Agreement, without any change to the aggregate compensation under the Agreement.

1. Capitalized terms used but not defined in this Amendment No. 3 shall have the meanings ascribed to them in the Agreement.
2. Exhibit B to the Agreement is hereby revised to replace the table in the exhibit labelled "CITY-WIIDE TREE TRIMMING AND MAINTENANCE SERVICES" first added by Amendment No. 1, with the table attached as Exhibit A hereto and incorporated herein by this reference.
3. All other terms and conditions of the Agreement, including Exhibit "B" remain in full force and effect.
4. This Amendment No. 3 may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.
