25CARRU022665 2/6/2025 12:35:00PM	CAL FIRE/ Riverside County Firefighters responded to a report of a hiker down in the hills at the end of Aspel Rd. Truck 76 arrived to find a 25-year-old male with a potential ankle injury. The patient was on a hiking trail. Star 9 was able to make access to the patient quickly and hoist the patient up. The patient was transported to the Menifee Global Medical Center, transferred to an AMR unit and then to the emergency room at the hospital. Injuries were suspected to be a possible ankle injury. No other injuries were reported during this event.
25CARRU033062 2/24/2025 1:45:00PM	CAL FIRE/Riverside County Fire Department responded to a reported residential structure fire at the location above. The first arriving company officer reported smoke coming from the garage. Companies were able to confirm that all occupants of the residence were evacuated. Crews contained the fire to the structure of origin, and two vehicles. Engine companies remained at the scene for approximately two hours for salvage and overhaul. One resident was assessed for a medical condition and was not transported. Menifee City Building and Safety red tagged the residence. Two adults and three dogs were displaced.
