

**AMENDMENT NO. 2 TO  
PROFESSIONAL SERVICES AGREEMENT  
TRAFFIC ANALYSIS SERVICES FOR THE ECONOMIC DEVELOPMENT CORRIDOR,  
NORTHERN GATEWAY AREA**

This is Amendment No. 2 ("Amendment No. 2") to that certain Professional Services Agreement ("Agreement") made on **March 27, 2024** between the City of Menifee ("City") and **KIMLEY-HORN AND ASSOCIATES, INC** ("Consultant") for **TRAFFIC ANALYSIS SERVICES FOR THE ECONOMIC DEVELOPMENT CORRIDOR, NORTHERN GATEWAY AREA**, as amended by that certain Amendment No.1 to the Agreement entered into on **January 2, 2025** ("Amendment No. 1"), which this Amendment No. 2 is made and entered into on \_\_\_\_\_, **2025** to extend the term of the agreement as indicated below:

1. Capitalized terms used but not defined in this Amendment No. 2 shall have the meanings ascribed to them in the Agreement.
2. The Parties further acknowledge that although the Agreement was originally set to terminate on December 31, 2024, the Parties continued to operate as though the Agreement were still in full force and effect up to and following the execution of Amendment No. 1. The Parties mutually agree to continue the uninterrupted effectiveness of the Agreement until the end of the Term of Services as revised by this Amendment No. 2 and any future amendment entered into by the Parties.
3. Section 1.1, "Term of Services" is amended to read as follows:

**1.1 Term of Services.** The term of this Agreement shall begin on the **March 27, 2024** and shall end on **June 30, 2025** unless the term of the Agreement is otherwise terminated or extended as provided for in Section 8. The time provided to Consultant to complete the Services required by this Agreement shall not affect the City's right to terminate the Agreement, as provided for in Section 8.

4. All other terms and conditions of the Agreement remain in full force and effect.
5. This Amendment No. 2 may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.
