# Capital Improvement Program



The Capital Improvement Program provides for the maintenance and improvement of the City's infrastructure which includes bridges, buildings, pavement rehabilitation, streets, sidewalks, storm drains, street lighting, and traffic signals.

## MISSION

To develop a comprehensive Five-Year Capital Improvement Program (CIP) based on:

- Priorities
- Budget
- Schedule

The five-year CIP is comprised of the upcoming fiscal Year budget and projections for the following four fiscal years.



The five-year CIP is updated entirely every other fiscal year.





# CIP PROJECT PLANNING

The CIP Division develops a set of planning tools that identify existing and projected community needs, such as:



## City General Plan:

Lists major infrastructure (transportation, facility, etc.)

## Pavement Management Program (PMP) Report:

Roadway surface condition analysis. Updated every 4 years

## Active Transportation Plan (ATP):

Bicycle and pedestrian Infrastructure.

## Master Drainage Plan (MDP):

Existing and future storm drain infrastructure study.

## Local Roadway Safety Plan (LRSP):



Analysis of roadway accidents and mitigation measures.

## Complete Streets Plan:

Complete networks, including multi-modal transportation (pedestrian, motorists, public transit, etc.)

## Parks and Trails Master Plan:

Recreational facilities.






# CIP PROJECT DEVELOPMENT & PRIORITY ASSIGNMENT

PRIORITY ASSIGNMENT	DESCRIPTION
1	Project is urgent & must be completed as soon as possible. Failure to address project impacts health, safety, or welfare of the community or has a potential significant impact on the financial wellbeing of the City. The project must be initiated, or financial opportunity losses may result.
2	Project is important and addressing it is necessary. The project impacts safety, law enforcement, health, welfare, economic base, and quality of life.
3	Project enhances quality of life & will provide a benefit to the community such as cultural, recreational, and/or aesthetic value, or is deemed as a necessary improvement to a public facility.
4	Project improves the community but does not necessarily need to be completed within a five-year capital improvement program time frame







## REVENUE OUTLOOK FOR FY 24/25

Adopted 2024/25 Budget included revenue growth across City's principal revenue sources, at a more modest/leveled pace from historical growth. Year to date revenues and projections for the new year, including CIP funding such as SB 1, do not forecast significant growth than originally adopted.
