## STATEMENT OF INTEREST

The Statement of Interest form provides an opportunity for District 2 residents to express your desire to serve on the Menifee City Council. ### Statement:

1. Why do you want to represent District 2, and what unique goals would you bring to the Council?

I would like to be appointed to the City Council because I believe I can lend a unique voice to city leadership. I also want to advocate for District 2 residents in order to bring needed services like a police substation and a community center to the district.

Secondly, I want to see our city continue to be a place where residents feel safe, good decisions are being made with regard to businesses coming to our city, and that we have enough entertainment options so that our residents don't have to spend their money in neighboring cities. We have to plug the retail, dining and entertainment leakage without oversaturating our city with businesses that few residents want or need.

My involvement in various community organizations has allowed me to expand on my public service. It has also afforded me the opportunity to see what the most critical needs are for our community. If appointed to the city council, I will be even more involved and will be regularly engaged with District 2 residents and others.

3. What are the top three issues facing Menifee residents, and what specific improvements or mitigation efforts do you believe are needed?

Need for more retail, entertainment and dining options

- o Mitigation: the city should offer reduced fees and other incentives through its restaurant incentive program. We are losing millions of dollars to neighboring cities because of our lack of restaurants and entertainment options.

Carve out a unique identity that will attract people from around our region

- o Mitigation: hold community meetings and offer input through online participation as to what Menifee residents feel our unique identity should be. We are not currently known for anything except, perhaps, being a bedroom community next to Murrieta. I elaborate more on this in question#4.

A need for balanced growth with regard to residential, commercial and preservation of open spaces

- o Mitigation: ensure the city's general plan, zoning and future developments allow for open spaces and parks, while incorporating enough space for future homes to be built.

4. What do you envision Menifee's "Unique Identity" to be?

There are a few options city leadership can pursue. They might include:

Building Menifee into a regional shopping powerhouse. I believe we can achieve something similar to (or better than) Victoria Gardens in Rancho Cucamonga and be anchored by a popular store like Bass Pro Shops. A walkable, safe and clean shopping complex can be constructed and maintained. The land immediately south of Lowe's and east of Santa Rosa Academy might be considered if available.

Amusement or Theme Park. Buena Park has Knott's Berry Farm. Carlsbad has LEGOLAND and Universal City has Universal Studios Hollywood. With Menifee's available land and an attractive location package, we can convince a major company to locate its theme park in our city. If successful, we will see resorts, hotels, and ancillary businesses formed around the park. This would significantly contribute to our tax revenues.

5. What is your perspective on the growth Menifee has experienced?

We should have smart growth. While we must continue to build enough homes to accommodate our growing city, we should also leave room for open spaces, parks and trails. Residents do not want to see Menifee become saturated with warehouse distribution centers or other structures that degrade their quality of life.

6. What role should the city play in attracting businesses and amenities, and how should the infrastructure to support these developments be funded?

A council standing committee could be created and tasked with working with the City Manager to attract retail, entertainment and dining businesses. Additionally, one member each from each of Menifee's commissions and committees would be assigned to this standing committee. The infrastructure to support these developments could come largely from developer fees and existing sales tax revenue (no new taxes should be levied for this effort). Businesses would also pay their share through permits and licenses.

7. According to a recent Channel 5 News report, nearly 80% of Menifee residents are rent burdened (>30% spent on housing), ranking the city as the most impacted in the state. Would you support the development of more diverse housing options to address this issue?

I am open to considering more housing options as long as they are not "project" type homes and the city does not pursue any form of rent control. Creating zoning allowing for a mixture of single-family homes, apartments, and less-expensive "tiny" homes might assist us in meeting our Regional Housing Needs Allocation numbers.

Desire to Serve and Background:

I would be honored to be appointed to the city council for District 2. I intend to advocate for District 2 residents in order to bring needed services like a community center and police substation to the district.

Secondly, I want to help our city continue to be a place where residents feel safe, good decisions are being made with regard to businesses coming to our city, and where we have enough retail, entertainment, and dining options so that our residents don't have to spend their money in neighboring cities.

I am a native of Philadelphia, Pennsylvania and am the oldest of six children. After graduating from high school in 1989, I enlisted in the United States Marine Corps. I spent 20 years in the Marines, while being assigned to various units. I deployed to the Persian Gulf War in 1990-91 and to Iraq in 2003 and 2008 during Operation Iraqi Freedom. After retiring from the military, I taught Junior ROTC at Murrieta Valley High School. From 2012-2024, I served as a senior district representative for the California State Senate.

Vision: I see Menifee as a safe, business-friendly city where the voices of the people are always heard and respected.
