24CARRU067740 5/6/2024 12:30:00PM	<p>Menifee Engine arrived to the location above and reported a construction crew had severed an approximate four inch natural gas line. So Cal Gas company arrived at scene and took over the incident. Encanto rd just north of Shadel Rd and Mclaughlin Rd will be closed for several hours while repairs are made.</p> <p>As of 05:40 PM the leak has been stooped and gas company crews will be on scene several hours for repair.</p>
24CARRU072223 5/14/2024 1:18:00PM	<p>CAL Fire/Riverside County Firefighters responded to a reported inaccessible rescue in the area of the above location. The victim was an injured hiker with a broken leg. Fire personnel were able to use GPS technology to find the exact location of the injured hiker and make ground access to the patient and provide medical care at the point of injury. Rescue 9 was able to hoist the patient to a ground ambulance for transport to an area hospital. Fire personnel were also able to extricate the victims dog from the trail.</p>
24CARRU074863 5/19/2024 11:55:00AM	<p>CAL Fire/Riverside County Firefighters responded to a reported residential structure fire at the above address. First Chief Officer at scene reported a single-story, single-family dwelling with nothing showing. Once crews gained access they found a small fire contained to the garage by the sprinkler system with minimal damage. Their will be no displacements.</p>
