

**AMENDMENT NO. 5 TO
CONTRACT SERVICES AGREEMENT FOR
CITY OF MENIFEE
CITYWIDE TREE TRIMMING AND MAINTENANCE SERVICES**

This is Amendment No. 5 (“Amendment No. 5”) to that certain Contract Services Agreement (“Agreement”) made on **January 18, 2023** between the City of Menifee (“City”) and **WEST COAST ARBORISTS, INC**, a California Corporation (“Contractor”) for **CITY OF MENIFEE CITYWIDE TREE TRIMMING AND MAINTENANCE SERVICES** as amended by that certain Amendment No. 1 to the Agreement entered into on **July 20, 2023** (“Amendment No. 1”), as amended by that certain Amendment No. 2 to the Agreement entered into on **March 22, 2024** (“Amendment No. 2”), and as amended by that certain Amendment No. 3 to the Agreement entered into on **May 20, 2024** (“Amendment No. 3”), as amended by that certain Amendment No. 4 to the Agreement entered into on **June 17, 2024** (“Amendment No. 4”), which this Amendment No. 5 is made and entered into on _____, **2024** to increase the scope of work and increase the compensation amount as indicated below:

1. Capitalized terms used but not defined in this Amendment No. 5 shall have the meanings ascribed to them in the Agreement.
2. SECTION 2.1, “Contract Sum” is amended to read as follows, increasing the contract amount by: **THREE HUNDRED SEVENTY ONE THOUSAND NINE HUNDRED SIXTY NINE DOLLARS AND ZERO CENTS (\$371,969.00)**.

SECTION 2.1 Contract Sum.

Subject to any limitations set forth in this Agreement, City agrees to pay Contractor the amounts specified in the Scope of Services and incorporated herein by this reference. The total compensation, including reimbursement for actual expenses, shall not exceed **ONE MILLION SEVEN THOUSAND SIX HUNDRED TEN DOLLARS AND TWENTY CENTS (\$1,007,610.20)** (the “Contract Sum”), unless additional compensation is approved pursuant to Section 1.10.

3. Exhibit B, “Scope of Services” is supplemented to include the supplement attached as Exhibit A hereto. The supplement to the “Scope of Services” is not intended to replace the original Exhibit B to the Agreement, but instead to augment and increase the scope of work listed in the original Exhibit B to the Agreement. The initial paragraph of the original Exhibit B, “Scope of Services”, to the Agreement is amended to read as follows:

EXHIBIT B

SCOPE OF SERVICES

CITYWIDE TREE TRIMMING AND MAINTENANCE SERVICES

Contractor shall provide City-Wide Tree Trimming and Maintenance Services in the amount not to exceed **ONE MILLION SEVEN THOUSAND SIX HUNDRED TEN DOLLARS AND TWENTY CENTS (\$1,007,610.20)** as further detailed in the following page(s).

4. All other terms and conditions of the Agreement remain in full force and effect.
5. This Amendment No. 5 may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.
