**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MENIFEE, CALIFORNIA, AUTHORIZING CERTAIN CITY OFFICIALS OF THE CITY OF MENIFEE OR DESIGNEE TO ACCEPT THE FISCAL YEAR 2023 EMERGENCY MANAGEMENT PERFORMANCE GRANT PROGRAM AWARD IN THE AMOUNT OF TWENTY-FOUR THOUSAND, SIX HUNDRED EIGHTY-FIVE DOLLARS (\$24,685.00), GRANT NO. 2023-0006, CFDA NO. 97.042 AND TO AUTHORIZE ALL DOCUMENTS IN THE FURTHERANCE THEREOF**

**WHEREAS**, the City of Menifee has applied for the Fiscal Year 2023 Emergency Management Performance Grant Program (EMPG) Award in the Amount of Twenty-Four Thousand, Six Hundred Eighty-Five Dollars (\$24,685.00), Grant No. 2023-0006, CFDA No. 97.042, as made available through and administered by the California Office of Emergency Services (“CalOES”) for fiscal year 2023; and

**WHEREAS**, the City Council desires the City Manager, Assistant City Manager, or designee to accept the aforementioned grant and to execute for and on behalf of the City of Menifee any document, including agreements, amendments, extensions, and grant award documents with CalOES, or other responsible government agency, for the purpose of obtaining federal financial assistance provided by the Fiscal Year 2023 Emergency Management Performance Grant Program (EMPG) Award in the Amount of Twenty-Four Thousand, Six Hundred Eighty-Five Dollars (\$24,685.00), Grant No. 2023-0006, CFDA No. 97.042.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MENIFEE, CALIFORNIA DOES RESOLVE, DECLARE, DETERMINE, AND ORDER AS FOLLOWS:**

**Section 3.** The City Council hereby authorizes, and does, accept the Fiscal Year 2023 Emergency Management Performance Grant Program (EMPG) Award in the Amount of Twenty-Four Thousand, Six Hundred Eighty-Five Dollars (\$24,685.00), Grant No. 2023-0006, CFDA No. 97.042.
