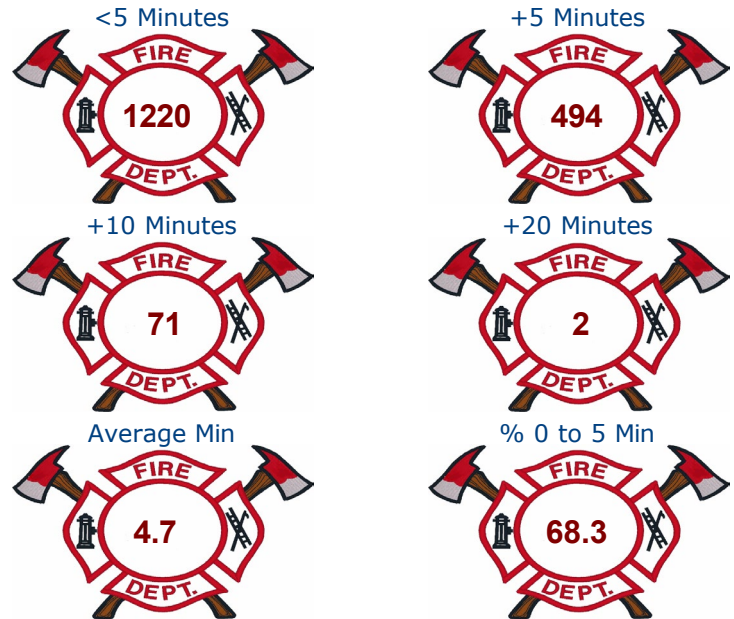

Significant Incidents

24CARRU185125 12/1/2024 2:15:00PM	<p>CAL FIRE and Riverside County Firefighters responded to a reported residential house fire. Engine 7 arrived at scene of a fire in a garage of the home. Access was limited into the garage due to the vehicle parked inside. The fire had spread into the living quarters of the home, firefighters were able to keep the fire from spreading further. All damages were contained to the original structure. Residents were at the scene, one adult male was evaluated for smoke inhalation, however refused to be transported for further review. Two adult males and one adult female were displaced through The American Red Cross. Menifee building and safety were requested to evaluate the property.</p>
24CARRU192195 12/13/2024 7:01:00PM	<p>CAL FIRE/Riverside County Fire Department responded to a reported residential structure fire at the location above. The first arriving company officer reported a single-story residence with smoke and fire coming the front door. Companies were able to confirm all occupants of the residences were evacuated. Crews located the fire in the fireplace and confirmed it was extinguished prior to arrival. The fire did activate two sprinklers inside the residence, causing moderate water damage with some smoke damage. Engine and truck companies remained at scene for approximately one hour for salvage and overhaul. Building and Safety, and Fire prevention will need to assess the structure.</p>
24CARRU192837 12/14/2024 9:14:00PM	<p>CAL Fire/ Riverside County Firefighters responded to a reported traffic collision at the above location. First unit at scene reported four vehicles with major damage with a total of six patients one requiring extrication. All six patients were transported to local hospitals with moderate to major injuries.</p> <p>As a result, McCall Blvd will be closed between Bradley Rd and north bound Onramp to interstate 215. for several hours while Menifee PD conducts its investigation.</p>
24CARRU192915 12/15/2024 12:31:00AM	<p>CAL Fire/Riverside County Firefighters responded to a reported traffic collision with extrication. First unit at scene reported three vehicles with a total of two patients with one requiring extrication. Crews extricated one patient within minutes of arrival and was transported to a local hospital. The second patient was also transported with minor injuries.</p>
