

## Significant Incidents

24CARRU155724 10/9/2024 1:01:00PM	CAL FIRE/ Riverside County Firefighters responded to a reported fire at the Sun City Mobile Home Park. Engine 7 arrived at an exterior fire in a carport. Firefighters were able to contain the fire to only one residence with minimal extension into the effected home. The home was unoccupied during the incident. Personnel were on scene for approximately one hour to ensure the fire was fully extinguished. The American Red Cross was contacted to assist with the displaced tenants. No injuries were reported at the scene. The cause is still under investigation.
