

**RESOLUTION NO. 24-\_\_\_\_\_**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MENIFEE, CALIFORNIA,  
APPROVING THE HERITAGE LAKE DRIVE NAME CHANGES TO EAST HERITAGE  
LAKE DRIVE, WEST HERITAGE LAKE DRIVE, SILVER LANE, AND UNDERWOOD  
WAY.**

**WHEREAS**, the City Council possesses the authority to rename an existing city street by resolution pursuant to Government Code Section 34091.1; and

**WHEREAS**, multiple streets are named “Heritage Lake Drive” within the City of Menifee; and

**WHEREAS**, the Community Development Department recommends changing the street name from “Heritage Lake Drive” to “East Heritage Lake Drive” for the street segment east of Menifee Road to Lindenberger Road; to “West Heritage Lake Drive” for the street segment west of Lindenberger Road to East Heritage Lake Drive; to “Silver Lane” for the segment west of Menifee Road and east of Junipero Road; and to “Underwood Way” for the street segment west of Junipero Road and east of Palomar Road; and

**WHEREAS**, the City Council discussed these street name changes at its regular meeting on October 2, 2024; and

**WHEREAS**, changing an existing street name is exempt from review under the California Environmental Quality Act, pursuant to 14 Cal. Code Regs. 15061(b)(3), because it can be seen with certainty that there is no possibility that the name change in question will have a significant effect on the environment.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Menifee, California does hereby resolve, declare, determine and order as follows:

**Section 1.** That the City Council of the City of Menifee hereby resolves to approve the street name changes for Heritage Lake Drive to “East Heritage Lake Drive” for the street segment east of Menifee Road to Lindenberger Road; to “West Heritage Lake Drive” for the street segment west of Lindenberger Road to East Heritage Lake Drive; to “Silver Lane” for the segment west of Menifee Road and east of Junipero Road; and to “Underwood Way” for the street segment west of Junipero Road and east of Palomar Road, as shown in Exhibit A, pursuant to the authority vested in the City Council by California Government Code section 34091.1.

**Section 2.** That the City Clerk and Public Works Department are hereby directed to take whatever steps are required by law to notify the public of said name change, including providing any required notices, including to the County of Riverside pursuant to California Government Code section 34092, and to proceed to make physical improvements to the street that reflect the intent of this resolution.
