A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MENIFEE, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, ORDERING THE LEVY AND COLLECTION OF THE CHARGES WITHIN THE COUNTY SERVICE AREAS WITHIN THE CITY OF MENIFEE FOR FISCAL YEAR 2021-22

WHEREAS, upon incorporation on October 1, 2008, the City of Menifee (City) assumed the responsibility for certain County Service Areas now within the City's jurisdictional boundaries, and now is responsible for the services and charges provided by County Service Areas 33, 43, 84, 86, 138, and 145 (collectively the "Area"); and

WHEREAS, the City Council has determined that it is necessary to continue the area charges in order to continue to provide the operating, maintaining and servicing of the improvements located within the Area; and

WHEREAS, on October 1, 2008, the City Council of the City of Menifee adopted all County of Riverside Ordinances in effect including Riverside County Ordinance No. 573; and

WHEREAS, Riverside County Ordinance No. 573 requires that the City Council annually shall cause to be prepared and filed with it a report of the services (hereafter referred to as the "Report"), parcels and charges provided by each County Service Area for the upcoming Fiscal Year; and

WHEREAS, The City Clerk has presented to the City Council, a Report in connection with the proposed levy and collection of charges upon eligible parcels of land within the Area, and the City Council did by previous Resolution approve such Report; and

WHEREAS, the City Council desires to levy and collect charges against parcels of land within the Area for the Fiscal Year commencing July 1, 2021 and ending June 30, 2022, to pay the costs and expenses of operating maintaining and servicing the improvements within the Area; and

NOW, THEREFORE BE IT RESOLVED, DETERMINED, AND ORDERED BY THE CITY COUNCIL FOR THE DISTRICT AS FOLLOWS:

Section 1. Following notice duly given, the City Council held a full and fair Public Hearing on July 7, 2021 regarding its Resolution Approving and or Amending the Report prepared in connection therewith; the parcels and collection of charges for the Area, and considered all oral and written statements, protests, and communications made or filed by interested persons.

Section 2. The Report and charges as presented to the City Council and on file in the office of the City Clerk are hereby confirmed as filed.

<u>Section 3.</u> The County Auditor-Controller of the County of Riverside shall enter on the County Assessment Roll opposite each parcel of land the amount of levy, and such levies shall be collected at the same time and in the same manner as the County Taxes are collected. After collection by the County, the net amount of the levy shall be paid to the City.

<u>Section 4.</u> The adoption of this Resolution constitutes the Area levy for the Fiscal Year commencing July 1, 2021 and ending June 30, 2022.

Section 5. The City Clerk is hereby authorized and directed to file the levy with the County Auditor-Controller upon adoption of this Resolution.

Section 6. A certified copy of the levy shall be filed in the office of the City Clerk and open for public inspection.
