# RESOLUTION NO. 21-\_\_\_\_

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MENIFEE, CALIFORNIA, ESTABLISHING BURGLAR ALARM PERMIT AND FALSE ALARM RESPONSE FEES

**WHEREAS**, the City Council of the City of Menifee has adopted Chapter 11.30 of the Menifee Municipal Code, establishing regulations for the operations of burglar alarm systems, including permit fees and fees to reimburse the City of Menifee ("City") for providing responses to false alarms, in such amounts as to be established by resolution of the City Council.

**WHEREAS**, on July 7, 2021, the City Council held a duly noticed public hearing concerning the fees proposed to be established herein at which time members of the public had the opportunity to review the documents presented to the City Council and provide oral comments to the City Council concerning fees set forth therein.

**WHEREAS**, for purposes of this Resolution, the term "false alarm" shall have that meaning as set forth in Chapter 11.30 of the Menifee Municipal Code.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Menifee does hereby resolve as follows:

**Section 1.** Each of the above recitals is true and correct and is adopted by the City Council.

<u>Section 2.</u> The fees and charges set forth in Exhibit A, attached hereto and incorporated by reference herein, are approved and adopted. The fees and charges set forth in Exhibit A do not exceed the reasonable cost of providing the services, facilities, and regulatory activities related to such fees and charges.

<u>Section 3.</u> All provisions of any previously adopted resolutions establishing or revising fees for alarm permit and false alarm response fees specified in this Resolution are hereby repealed and superseded by the provisions of this Resolution and the fees adopted herein.

**Section 4.** The provisions of this Resolution shall become operative as of the effective date of Chapter 11.30 of the Menifee Municipal Code.

<u>Section 5.</u> The City Manager is hereby authorized to all things necessary to implement this Resolution.

**Section 6.** The City Clerk shall certify the adoption of this Resolution.

- Hearing Filing Fee: \$25
- If an invoice for the service charge is unpaid sixty (60) days after mailing, a penalty of ten percent (10%) shall be charged, and an additional one and one-half percent (1.5%) per month shall be charged until the charges and penalties are paid in full.
