

#### **Comments/Narrative**

CALFIRE/Riverside County Fire Department responded to a disabled semi truck on Menifee Rd. between Simpson and McCall. The semi truck was experiencing a ruptured fuel tank and leaked approximately 50-75 gallons of diesel fuel in the northbound number 1 lane of Menifee Rd. CALFIRE/Riverside County Fire Department Hazardous Materials Team arrived at scene and captured the leaking fuel from he active leak and offloaded to remaining fuel still in the tank. City of Menifee Public works and Riverside County Environmental Health remained on scene to coordinate clean up efforts.


