RESOLUTION NO. 22-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MENIFEE, CALIFORNIA, RECITING THE FACTS OF THE GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 8, 2022, DECLARING THE RESULTS OF THE ELECTION AND RECITING SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted in the City of Menifee, California, on Tuesday, November 8, 2022, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law for candidates; candidates were nominated to fill the offices as provided by law; voting precincts were properly established; election officers were appointed; and in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the laws of the State of California relating to general law cities; and

WHEREAS, in compliance with Resolution No. 22-1171, adopted June 15, 2022, the Riverside County Registrar of Voters canvassed the returns of the election and has certified the results to the City Council; and

WHEREAS, pursuant to Elections Code Section 10229 the City Council adopted Resolution No. 22-1199 and appointed Dean Deines as the District 4 Councilmember; and

WHEREAS, pursuant to Elections Code Section 10229 Councilmember Deines shall serve exactly as if elected at the municipal election; and

WHEREAS, the results of the election are received, attached and made a part hereof as Exhibit A.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MENIFEE, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

- 1. That the whole number of ballots cast in the City was 17,089.
- 2. That the names of persons voted for at the election for Member of the City Council Term Ending December 2026 are as follows:

District 2 – Ben Diederich

Angela "Angel" Nevin Ricky Estrada

Altie Holcomb

3. That the City Council does declare and determine that:

Ricky Estrada was elected as Member of the City Council for the full term of four years, for District 2 - ending December, 2026.

4. The City Clerk shall enter on the record of the City Council of the City, a statement of the result of the election, showing: (1) The whole number of ballots cast in the City; (2) The names of the persons voted for; (3) For what office each person was voted for; and the

number of votes given at each precinct to each candidate.

- 5. That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the office of Member of the City Council to which they have been elected.
- 6. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
