

**FIRST AMENDMENT TO THE
AGREEMENT FOR
PROFESSIONAL MEDICAL SERVICES
(Adult / Adolescent Forensic Services)
BETWEEN COUNTY OF RIVERSIDE AND CITY OF MENIFEE**

This First Amendment to the Agreement for Professional Medical Services (Adult / Adolescent Forensic Services) (First Amendment), is entered into by and between the **County of Riverside** (COUNTY), a political subdivision of the State of California, on behalf of the **Riverside University Health System Medical Center** (HOSPITAL) and **The City of Menifee**, a municipal corporation of the State of California, on behalf of the **Menifee Police Department** (CONTRACTOR), sometimes collectively referred to as the “Parties” or individually referred to as a “Party.”

WHEREAS, COUNTY and CONTRACTOR have entered into that certain Agreement for Professional Medical Services (Adult / Adolescent Forensic Services), and effective January 1, 2020 (Agreement), whereby COUNTY agreed to provide CONTRACTOR with professional medical services in the specialty practice of Adult / Adolescent Forensic Services (SPECIALTY); and

WHEREAS, COUNTY and CONTRACTOR desire to amend the Agreement to exercise the option to renew and extend the period of performance as set forth in the Agreement;

NOW THEREFORE, the Parties agree as follows:

1. Term. Section 2.1 Term is hereby amended to read as follows:

“This Agreement shall be effective upon signature of this Agreement by both parties and continues in effect through June 30, 2023, unless terminated earlier. This Agreement may be renewed by written amendment for up to two (2) additional years through June 30, 2025.

2. Miscellaneous. All other terms and conditions of this Agreement are to remain unchanged.

3. Effective Dates. This First Amendment to the Agreement shall become effective July 1, 2023 through June 30, 2024.
