A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MENIFEE, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, DECLARING ITS INTENTION TO CONTINUE COUNTY SERVICE AREA CHARGES WITHIN THE CITY FOR FISCAL YEAR 2023-24 AND NOTICING A PUBLIC HEARING

WHEREAS, upon incorporation on October 1, 2008, the City of Menifee (the "City") assumed the responsibility for certain County Service Areas ("CSAs") now within the City's jurisdictional boundaries, and now is responsible for the services and charges provided by County Service Areas 33, 43, 84, 86, 138, and 145; and

WHEREAS, the City Council has determined that it is necessary to continue the CSA charges within such areas in order to continue to provide such extended services; and

WHEREAS, on October 1, 2008, the City Council of the City of Menifee adopted all County of Riverside Ordinances in effect including Riverside County Ordinance No. 573; and

WHEREAS, Riverside County Ordinance No. 573 requires that the City Council annually shall cause to be prepared and filed with it a report of the services, parcels and charges provided by each CSA for the upcoming Fiscal Year; and

WHEREAS, upon filing of such report with the City Clerk, the City Council shall cause to be noticed and thereafter conduct a public hearing to hear and consider testimony regarding the continuation of charges for such extended service within such County Service Areas within the City; and

WHEREAS, the City Clerk has confirmed such report has been received and filed for Fiscal Year 2023-24 for such County Service Areas within the City; and

NOW, THEREFORE BE IT RESOLVED, DETERMINED, AND ORDERED BY THE CITY COUNCIL FOR THE DISTRICT AS FOLLOWS:

<u>Section 1.</u> The City Council accepts the findings set out above as true and correct and accepts the report of services, parcels, and charges for County Service Areas 33, 43, 84, 86, 138, and 145 attached and incorporated as Exhibit "A".

<u>Section 2.</u> The City Council directs the City Clerk to publish notice of a public hearing to be conducted on <u>Wednesday, June 21, 2023 at 6:00 p.m.</u> (or as soon thereafter as it may be heard) in the City Council Chambers, located at 29844 Haun Rd. Menifee, CA for the purpose of allowing public testimony regarding the enactment of proposed Fiscal Year 2023-24 County Service Area charges.

<u>Section 3.</u> That the City Clerk shall publish a Notice of Public Hearing once a week for two weeks pursuant to Government Code Section 6066.

Any person affected by the proposed charges may submit written comments or protest to the City Clerk at any time before the conclusion of the hearing or may appear in support of, or opposition to, the proposals at the time of hearing.
