**A PUBLIC HEARING** has been scheduled, pursuant to the City of Meniffee Municipal Code, before the **CITY OF MENIFEE PLANNING COMMISSION** to consider the project shown below:

**Project Title:** “Normandy Road Pedestrian Improvement Project” CIP No. 22-08

**Project Location:** The Project site is generally located west of Interstate 215 (I-215), south of State Route (SR-) 74, and north and east of I-15 in the City of Meniffee. The Project site is located on the north side of Normandy Road between Berea Road and La Ladera Road.

**The Planning Commission will consider the adoption of a Mitigation Negative Declaration for the following project at a public hearing:**



The City of Meniffee (City) proposes the Normandy Road Pedestrian Improvements Project (“Project”) which includes the construction of a pedestrian trail extending from existing sidewalks from the west and east along the north side of Normandy Road. The Project would include the demolition and grading of existing substrate, the construction of a pedestrian walkway, the installation of a pedestrian handrail and footing, site stabilization, striping of roadways, and final erosion mitigation.

The pedestrian trail would be approximately 1,433 linear feet abutting the northern edge of pavement of Normandy Road and would be 10 feet wide. The Project would provide headwall improvements for the existing stormwater infrastructure that allows for drainage of an existing stormwater drainage channel. The trail would be constructed with asphalt concrete material and match grade with the existing Normandy Road.

**Environmental Information:** The City of Menifee Community Development Department has determined that the above project will not have a significant effect on the environment and has recommended adoption of a Mitigated Negative Declaration (MND). The Menifee Planning Commission will consider the proposed project and the proposed MND at the public hearing. In addition, the project site is not included on a list of hazardous materials sites compiled pursuant to Government Code Section 65962.5 (California Department of Toxic Substances Control list of various hazardous sites).

**Any person wishing to comment on the proposed project may do so in writing between the date of this notice and the public hearing and be heard at the time and place noted above. All comments must be received prior to the time of public hearing. All such comments will be submitted to the Planning Commission, and the Planning Commission will consider such comments, in addition to any oral testimony, before making a decision on the proposed project.**

**If this project is challenged in court, the issues may be limited to those raised at the public hearing, described in this notice, or in written correspondence delivered to the Planning Commission at, or prior to, the public hearing. Be advised that as a result of public hearings and comment, the Planning Commission may amend, in whole or in part, the proposed project. Accordingly, the designations, development standards, design or improvements, or any properties or lands within the boundaries of the proposed project, may be changed in a way other than specifically proposed.**
