## **RECOMMENDED ACTION**

1. Introduce an Ordinance amending Title 8 of the Menifee Municipal Code to modify appendices included in Sections 8.04.010, 8.05.010, 8.12.010, and 8.16.010 of the 2022 California Building Standards Code (CBSC).

## DISCUSSION

The City Council adopted the 2022 California Building Standards Code (CBSC) provisions on November 16, 2022, and the adopted code was submitted to the California Department of General Services for review.

On April 12, 2023, the Department of General Services returned the adoption with comments to include missing findings for certain appendices within Sections 8.04.010, 8.05.010, 8.12.010, and 8.16.010.

Upon subsequent review of the findings to support the adopted appendices, staff has determined that several of the appendices were adopted in error, as they were not environmentally or geographically relevant, or they duplicated existing code and were determined redundant. Therefore, and in compliance with the California Department of General Services, the proposed code Amendment will replace Sections 8.04.010, 8.05.010, 8.12.010, and 8.16.010 in their entirety as reflected in Exhibit A of the proposed Ordinance.

A comprehensive comparison of the sections included in Ordinance 2022-364, as adopted, and the proposed ordinance are illustrated in the following table:
