AMENDMENT NO. 6 TO PROFESSIONAL SERVICES AGREEMENT ENVIRONMENTAL AND CIVIL ENGINEERING DESIGN SERVICES ON THE HOLLAND RD/I-215 BRIDGE OVERCROSSING PROJECT, CIP #13-03

This is Amendment No. 6 ("Amendment 6") to that certain Professional Services Agreement ("Agreement") made on <u>April 16, 2014</u> between the City of Menifee ("City") and T.Y. LIN INTERNATIONAL ("Consultant") for ENVIRONMENTAL AND CIVIL ENGINEERING DESIGN SERVICES ON THE HOLLAND RD/I-215 BRIDGE OVERCROSSING PROJECT, CIP #13-03 as amended by that certain Change Order to the Agreement entered into on April 14, 2016 ("Amendment No. 1"), and that certain Amendment No.2 to the Agreement entered into on July 18, 2018 ("Amendment No. 2"), and that certain Amendment No. 3 entered into on May 1, 2019 ("Amendment No. 3"), and that certain Amendment No. 4 is entered into on September 1, 2021 ("Amendment No. 4"), which this Amendment No. 5 is made and entered into on May 4, 2022 ("Amendment No. 5"), which this Amendment No. 6 is made and entered into on , 2023 to extend the term of the Agreement, increase the compensation amount, and augment the scope of services as indicated below:

1. Capitalized terms used but not defined in this Amendment No. 6 shall have the meanings ascribed to them in the Agreement.

Section 1.1, "Term of Services" is amended to read as follows:

- <u>1.1</u> <u>Term of Services.</u> The term of this Agreement shall begin on the <u>April</u> <u>16, 2014</u> and shall end on <u>December 31, 2024</u> unless the term of the Agreement is otherwise terminated or extended as provided for in Section 8. The time provided to Contractor to complete the services required by this Agreement shall not affect the City's right to terminate the Agreement, as provided for in Section 8.
- <u>SECTION 2</u>, "Compensation" is amended to increase the maximum compensation by Seventy Five Thousand One Hundred Fifty Nine Dollars and Zero Cents (\$75,159.00), and is amended to read as follows:

SECTION 2. COMPENSATION.

City hereby agrees to pay Consultant a sum not to exceed **Two Million Five Hundred Seventy One Thousand Six Hundred Sixty Seven Dollars and Zero Cents (\$2,571,667.00)** notwithstanding any contrary indications that may be contained in Consultant's proposal, for the Services to be performed and reimbursable costs incurred under this Agreement. In the event of a conflict between this Agreement and Exhibit A, regarding the amount of compensation, this Agreement shall prevail. City shall pay Consultant for the Services rendered pursuant to this Agreement at the time and in the manner set forth herein. The payments specified below shall be the only payments from City to Consultant for the Services rendered pursuant to this Agreement. Consultant shall submit all invoices to City in the manner specified herein. Except as specifically authorized in advance by City, Consultant shall not bill City for duplicate services performed by more than one person. 3. Exhibit A, "Scope of Services" is supplemented to include the supplement attached as Exhibit A hereto. The supplement to the "Scope of Services" is not intended to replace the original Exhibit A to the Agreement, but instead to augment and increase the scope of work listed in the original Exhibit A to the Agreement. The initial paragraph of the original Exhibit A, "Scope of Services", to the Agreement is amended to read as follows:

SCOPE OF SERVICES

Consultant shall provide ENVIRONMENTAL AND CIVIL ENGINEERING DESIGN SERVICES ON THE HOLLAND RD/I-215 BRIDGE OVERCROSSING PROJECT, CIP #13-03 in the amount not to exceed **Two Million Five Hundred Seventy One Thousand Six Hundred Sixty Seven Dollars and Zero Cents (\$2,571,667.00)** as further detailed in the following page(s).

- 4. All other terms and conditions of the Agreement remain in full force and effect.
- 5. This Amendment No. 6 may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.

SCOPE OF WORK

Amendment 6

The Holland Road / I-215 Overcrossing project needs additional engineering design work to revise existing approved plans for field conditions.

5.2 Construction Support

TYLI will address City of Menifee's and Contractor requested revisions to plans and change of approved work from ready for construction design documents.

- a) Civil:
 - Revisions to Industry Circle cul-de-sac for unforeseen or out-of-place locations of existing utilities from as-built plans and conflicts associated with proposed utilities. TY Lin will provide technical support for request for information or clarification (RFI/RFC) from the Construction Manager, review the request and the appropriate sections/drawings of the technical documents, and prepare a written response for the Construction Manager's response to the Contractor.

TYLI will issue design changes (NDC) to revise the plans, profiles, details, quantities sheets, and estimates and specifications as needed for differing field conditions and utility conflicts.

2. Revisions to Grading and Drainage systems to accommodate relocation of SCE facilities. TY Lin will revise the existing grading and drainage plans between Willowood Way and Hanover to

facilitate a request from SCE utility to relocate electrical utility which was built in a different area than as shown on utility as-built sheets and conflicts with proposed drainage systems. Re-design will be based on City of Menifee standards.

b) Structures:

1. TY Lin will make revisions to existing bridge and MSE structures plans and calculations to accommodate Contractor requested changes for widened girder flares, MSE wall architectural details, and calculation analysis of Pile Bent CIDH construction anomalies.

Recycled Water Irrigation Plans: EMWD Requested Revisions

- DEA will make plan revisions following prior approved plans based on the redline set provided by EMWD. Some of
 these items include callouts / notes being requested, WM data, recycled water signs, POC information, EMWD
 details, and fence updates to depict separation of areas.
- DEA will prepare EMWD exhibits (MicroStation format per the prior approved plans by the City of Menifee and Caltrans). Updating symbols, format and title block edits often required by EMWD are not included in our scope of services.
- DEA landscape architects and irrigation specialists will review RFI's and make changes to the plans if required.
- DEA will provide a response to the specification RFI's.
- DEA will be available for up to 4 site visits during construction: mainline pressure testing and verification of burial depth, lateral line installation and irrigation equipment installation (valves, QC's, etc.), irrigation coverage test, and observation of plant installation, concrete mow curbs (recycled water separation), and plant spacing to meet City / Caltrans standard specifications.
- DEA will prepare As-Built plans from contractor redlines and provide plans digitally (hard copy mylar plans are not included at this time).


