RECOMMENDED ACTION

1. Accept the public improvements for streets/drainage, water, recycled water, and sewer systems for Plot Plan 2017-042, Wellquest Senior Living, located on the east side of Antelope and north of Aldergate Drive; and
2. Authorize the City Engineer to release the posted securities per the City's Standard Policies.

DISCUSSION

Wellquest Menifee, LLC ("Wellquest") is the developer of Wellquest Senior Living, a 118-unit assisted living facility on a 4.86 acre property. The property is located on the east side of Antelope Road and north of Aldergate Drive as depicted in the attached project map. As part of the development requirements, Wellquest constructed streets and drainage, water, recycled water and sewer system improvements.

Wellquest has now completed construction of these facilities and is requesting acceptance of the completed improvements into the City's maintenance system. Staff has inspected the completed improvements and have determined that the improvements have been constructed in accordance with City specifications and standards, and that all project conditions of approval have been met to release the performance security and labor and materials security in accordance with City policy. A 10% warranty security would be held for a period of one year in accordance with the City Municipal Code. The original posted security improvements are listed in Table 1 on the following page.
