RECOMMENDED ACTION

- 1. Approve and authorize the City Manager (or his designee) to execute a Professional Services Agreement with West Coast Arborist, Inc. for citywide tree trimming and maintenance services in the amount not-to-exceed \$176,402 for the remainder of Fiscal Year (FY) 2022/2023; and
- 2. Authorize the City Manager to execute agreement amendment(s) for the remainder of FY 2022/2023, and an additional four one-year amendments for annual services, at the City's discretion, and contingent on availability of the corresponding budget.

DISCUSSION

The City of Menifee's Community Service Department, Parks Division, oversees the ongoing trimming and maintenance of approximately 8,000 trees of varied species. The trees are located at different locations throughout the City including parks, right-of-way, and city facilities.

On October 20, 2022, staff issued a Request for Proposal (RFP) No. 2023-4 for Citywide Tree Trimming Services. The services would include, at minimum, all labor, equipment, materials, tools, and services necessary for tree pruning, tree removal, stump grinding, and emergency services.

The City received five proposals from the following firms:

- Community Tree Service
- Integrity Arborist and Ecoscape
- Mariposa Tree Management
- Stay Green
- West Coast Arborist, Inc.

An evaluation committee consisting of City staff evaluated the submittals. As part of the City's RFP process, the firms were evaluated based on the criteria set forth in RFP 2023-4 which included the experience/qualifications of the firm, references, project/services experience, cost proposal, and quality of responsiveness of the proposal.

Following the evaluation process and reference checks, City staff determined that West Coast Arborist, Inc. was the most qualified to conduct the requested services.

All the tabulated results from the evaluations are listed in Table 1 below:
