RECOMMENDED ACTION

- 1. Accept the public improvements for streets, drainage, water, sewer, and survey monuments for Tract Map 36485-6, Audie Murphy Ranch, located at the southwest corner of Bridle Gate Way and Audie Murphy Road North; and
- 2. Authorize the City Engineer to release 90% of the posted securities per the City's Standard Policies.

DISCUSSION

Sutter Mitland 01, LLC is the developer of Audie Murphy Ranch (AMR) Tract 36485-6, a subdivision of 21.19 gross acres into 86 lots for residential purposes. The tract is located at the southwest corner of Bridle Gate Way and Audie Murphy Road North, as depicted in the attached project map. As part of the development requirements, Sutter Mitland 01, LLC, constructed streets, drainage, water, and sewer system improvements and installed survey monuments.

Sutter Mitland 01, LLC has now completed construction of these facilities and is requesting acceptance of the completed improvements into the City's maintenance system. Staff has inspected the completed improvements, determined that the improvements have been constructed in accordance with City specifications and standards, and verified that all project conditions of approval have been met to release the performance security and labor and materials security in accordance with City policy. A 10% warranty security would be held for a period of one year in accordance with the City Municipal Code. The original posted securities for the improvements and the monuments are listed in Table 1 and Table 2 on the following page.
