RECOMMENDED ACTION

 Approve and authorize the City Manager to execute Professional Services Agreements with Searle Creative Group LLC, Tripepi Smith and Associates, Inc., and Mind and Mill LLC, in an aggregate amount not-to-exceed \$40,000 for Fiscal Year (FY) 2023/2024 and \$40,000 for FY 2024/2025 for On-Call Graphic Design Services; and

2. Authorize the City Manager to approve three, one-year extensions in an amount not-to-exceed \$40,000 annually.

DISCUSSION

On April 27, 2023, the City issued Request for Proposal (RFP) No. 2023-17 for On-Call Graphic Design Services to assist the Communications Division and Economic Development Department with the development of collateral materials such as logos, templates, infographics, brochures, banners, direct mail, and promotional items on an as-needed basis throughout the year.

RFP Process

A total of 12 proposals were received by the submittal deadline of May 29, 2023, from the following firms:

- 3. Class Act Designs

A comprehensive evaluation of the proposals received was completed by the review committee comprised of City staff. Proposals were reviewed and ranked based on the qualifications and experience of the firms and their project team, service delivery approach, and cost. Interviews were conducted with Mind and Mill LLC and Geographic, who tied for third place following the proposal review.

Following the evaluation, interview and reference checks, City staff determined that Searle Creative Group LLC, Tripepi Smith and Associates, Inc., and Mind and Mill LLC, were best qualified to provide On-Call Graphic Design Services for the City. Each of these firms have a broad range of graphic design experience serving both public and private sector clients.

The proposed Professional Services Agreement (PSA) term is for a two-year period extending from August 2, 2023, through June 30, 2025, with three, one-year extensions. The PSA extension terms allow for an annual rate increase of up to 3% per year rate based upon the Consumer Price Index (CPI) for the Riverside-San Bernardino-Ontario published by the Bureau of Labor Statistics. Any rate increases above 3% would require an agreement amendment reviewed and approved by the City Council.

The On-Call Agreements will provide access to three qualified firms able to meet the City's graphic design requirements on an as-needed basis. This will help to eliminate the potential for capacity constraints should any of the selected firms be unable to meet the City's scheduling/support needs on a project. As projects arise, City staff will acquire estimates from the authorized graphic design firms based upon the required scope of work. Projects will be awarded from among the On-Call Graphic Design firms based upon the project cost considered in combination with the firm's capabilities and ability to complete each project within the required timeframe.

FISCAL IMPACT

The estimated fiscal impact for On-Call Graphic Design Services is set to an aggregate not-to-exceed amount of \$40,000 annually in FYs 2023/2024 and 2024/2025 for a total of \$80,000. The associated costs have been included as part of the adopted FYs 2023/2024 and 2024/2025 budgets within the Communications Division Account No. 100-4121-52800 - Professional Services (\$30,000) and Economic Development Department Account No. 100-4350-52800 - Professional Services (\$10,000). Funding for the three additional one-year renewals would be established as part of the respective year's operating budget. No additional budget appropriation action(s) are required.
