RECOMMENDED ACTION

1. Accept the public improvements for streets, drainage, water, recycled water, and sewer systems, as well as subdivision monuments for Tract Map No. 36485-9, Audie Murphy Ranch, located on the south side of Audie Murphy Road North at Patriot Drive; and

2. Authorize the City Engineer to release the posted securities per the City's Standard Policies.

DISCUSSION

Audie Murphy Ranch ("AMR") Tract Map No. 36485-9 is a subdivision of 25.99 gross acres into 126 lots for residential purposes. The tract is located on the south side of Audie Murphy Road North at Patriot Drive, as depicted in the attached project map. As part of the development's requirements, Sutter Mitland 01 LLC, a Delaware limited liability company ("Developer"), constructed streets, drainage, water, recycled water, and sewer system improvements and installed survey monuments.

The Developer has now completed construction of these facilities and is requesting acceptance of the completed improvements into the City's maintenance system. Staff has inspected the completed improvements, determined that the improvements have been constructed in accordance with City specifications and standards, and verified that all project conditions of approval have been met to release the performance security and labor and materials security in accordance with City policy. A 10% warranty security would be held for a period of one year in accordance with the City Municipal Code. The original posted improvement securities are listed in Table 1 and Table 2 on the following page.
