RECOMMENDED ACTION

- 1. Adopt a resolution repealing and replacing Resolution No. 21-1027 to amend and adopt a list of projects for Fiscal Year 2021-22 funded by Senate Bill 1: The Road Repair and Accountability Act of 2017; and
- 2. Authorize the Public Works Director or his designee to re-submit the required list of projects and Resolution to the California Transportation Commission.

DISCUSSION

On June 2, 2021 the City Council approved the adopted list of projects for Fiscal Year 2021-2022 funded by Senate Bill 1 ("SB 1") along with Resolution No. 21-1027 as required by the California Transportation Commission ("CTC"). The adopted list of projects were as follows:

- **Menifee Road Resurfacing (Holland Road to Newport Road)**. This project will rehabilitate approximately 1 mile of existing asphalt concrete pavement through the cold-recycling in-place method, upgrade pedestrian ramps to comply with the Americans with Disabilities Act, install an approximately 500 foot long raise median, and stripe dedicated bicycle lanes.

- **Tradewinds Community (Romoland)**. This project will rehabilitate existing local roads by grinding and replacing the existing asphalt pavement.

Streets and Highway Code Section 2034(a)(1) requires that prior to receiving an apportionment of Road Maintenance and Rehabilitation Account ("RMRA") funds the City must adopt a list of all projects proposed to receive funding from the RMRA. This list must be adopted by City Council Resolution at a regular public meeting and must include a description and the location of each

proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement.

Resolution No. 21-1027 set forth the list and approved adoption package submitted to the CTC for review and approval of funding. It was discovered, however, that the Resolution did not include the required "useful life" language for the Menifee Road Resurfacing from Holland Road to Newport Road Project.

In order to ensure the City obtains the necessary funding, and so as to avoid project delay, staff recommends to repeal and replace Resolution No. 21-1027 with a resolution that incorporates the "useful life" language and will read as follows:

3. The following previously proposed and adopted projects may also utilize Fiscal Year 2021-22 Road Maintenance and Rehabilitation Account revenues in their delivery. With the relisting of these projects in the adopted fiscal year resolution, the City is reaffirming to the public and the State our intent to fund these projects with Road Maintenance and Rehabilitation Account revenues:

- Menifee Road Resurfacing (Holland Road to Newport Road): This project proposes to reconstruct the entire roadway surface with an innovative method for pavement restoration: Cold-in-place Recycling (CIR). In addition, the project will retrofit existing ADA ramps, install approximately 500 feet long raised median, stripe dedicated bicycle lanes, and re-stripe the roadway. Construction will start on March 2022 and completed by June 2022. <u>The project is estimated to have a useful life of 25 years.</u>

The City estimates receiving \$1,827,490 in RMRA funds in FY 21-22. If the City fails to submit the required list of projects and Resolution, the funds that were otherwise apportioned to the City will be redistributed to other agencies.
